HIGHLIGHTS FROM THE YEAR

- 187 young women and men were educated on human rights, gender equality, critical and creative thinking, and increased their leadership abilities through various projects of Democracy Today NGO.

- **up to 1000** indirect beneficiaries affected by the project.

- increase of knowledge and leadership among the projects' participants **by 72% in average**.

- understanding of gender equality concept increased among project beneficiaries from target communities **by 78% in** average.

- 32 young people from displaced and disadvantaged communities got skills on how to write CV, prepare for the job interview and became competitive in the labor market.

- a network of 134 human rights organizations and individuals established as a result of annual "International Young Women's Peace and Human Rights Award" and "International Conference".

- 6 mock elections were held for youth from

different communities of Armenia to increase civic education.

- **3 small projects** have been implemented by women's groups from bordering communities of Armenia.

- 4 publications have been initiated, which include a series of articles, research studies and assessment reports.

- 4 awards

have been granted to exceptional women for "their dedication, human rights and peacebuilding work"

- **2 special diplomas** have been handed to the

individuals/institutions "for protecting the human security and outstanding work in protecting human rights and dignity".

- 7 online meetings organized with wellknown experts from throughout the world to raise awareness on the conflict-related situation and its impact on the Republic of Armenia.

- an international conference with the participation of women, leaders, human rights defenders and peacebuilder from **17 countries** organized.



OUR WORK THROUGHTOUT THE WORLD

Apart from the local and regional work Democracy Today NGO also works internationally.

We involved participants from South Caucasus including Armenia, Georgia Azerbaijan and Nagorno-Karabakh. Region of North Caucasus including Chechnya, Ingushetia, Kabardino-Balkaria and North Ossetia. Middle East through Syria, Iraq and Lebanon, South America through Colombia, North Amirian through United States of America, Europe through Belgium and Cyprus.

And these are only the countries from which laurates of International Young Women's Peace Award are coming.



OUR MAIN PROJECTS

IMPLEMENTING WOMEN, PEACE AND SECURITY RESOLUTION AT THE BORDER COMMUNITY OF ARMENIA (SUPPORTED BY THE AUSTRIAN DEVELOPMENT AGENCY)

The overall goal of the proposed project is to empower 40 displaced and local women from the communities of Gegharkunik Province with the knowledge and skills to change their lives and invest in the economic development of the communities. Through the provision of knowledge of protecting women's rights and provision of small grants to help women start joint economic and educational activities, investing in the enhancement of social cohesion and helping to the successful integration of displaced women into the host communities.



YOUTH \$CHOOL OF CREATIVE THINKING (\$UPPORTED BY THE MINI\$TRY OF FOREIGN AFFAIR\$ OF NETHERLAND\$

The overall goal of the project was to empower young and muddled aged members of the rural communities with the comprehensive knowledge of fundamental human rights, legal instruments and political situation making them able to define fake news. Initially, the project was designed for youth however, later extended to middle-aged parents, which was the suggestion brought up by the young participants. 12 communities throughout Armenia took part in the project, bringing together 40 community leaders.



WFM/IGP (WORLD FEDERALIST MOVEMENT/ INSTITUTE FOR GLOBAL POLICY)

The project aimed to strengthen implementation of the concept "Responsibility to protect" (R2P) though organizations of webinars in cooperation with leading institutions. The consequences of 44-day war and the crimes the committed during the war have been introduced in the context of international law and R2P.



OUR MAIN PROJECTS

U-18 (SUPPORTED BY THE GERMAN-RUSSIAN EXCHANGE (DRA))

The aim of the project was to introduce the concept of U18 (Under 18 years) elections in Armenia.

U-18 is a sustainable method in civic education and youth policy, as well as, the establishment of five regional U18 coordination center in the regions and embedding of sustainable regional youth participation culture and creating of a networking platform for partner organizations of several regions.

The project was implemented in 5 provinces of Armenia.



SUCCESSFUL INTEGRATION OF THE DISPLACED YOUTH (SUPPORTED BY UMCOR-ARMENIA FOUNDATION)

The project aims to provide displaced youth with appropriate knowledge and practical skills that will help them find their niche in the labor market. It will allow those displaced people who cannot return to Artsakh not to leave Armenia, but to get opportunities and paths for future professional development in the country, having a positive impact on both their dignified future and economic development of the country.



CITIZEN ENGAGEMENT IN CONFLICT IMPACTED COMMUNITIES (SUPPORTED BY THE NATIONAL ENDOWMENT FOR DEMOCRACY (NED)

The project aims to invest in increasing the capacities of

youth from conflict-affected communities to contribute to the peace process, as well as build connections between communities in Nagorno-Karabakh (Artsakh) and the bordering regions of Armenia. The project aims at implementing UNSC Resolution 2250 on Youth, Peace and security.



OUR PUBLICATIONS

YOUTH \$PEAK\$ PEACE



The publication includes visions and perceptions on the peace of youth from Tavush bordering the province of Armenia and Artsakh. The study presents the dynamic change in perceptions from the first assessment, which took place long before the Tavush war, and visions after the first brief clashes at the borders of Tavush and followed by the 44day full-scale destructive war. Another important trait of this study is that it includes chapters written by the young local experts, bringing their personal insight.

NEVER AGAIN!!! 44 DAY\$ WAR: WAR CRIME\$ AND INTERNATIONAL LAW



The publication is based on the facts and documents collected by the Ombudsmen of Armenia and Artsakh, International organizations and media sources aim to provide with the analysis of the war crimes committed during this short, but devastating war. 

INTERNATIONAL CONFERENCE 2021

The Annual International Conference entitled "Displacement of women: gender implications and search for viable solutions to protect human rights" organized by "Democracy Today" took place in Yerevan, Armenia on December 16 and 17 of 2021. As its previous conferences, this one also aimed to strengthen the implementation of UNSC Resolution 1325.

The annual conference was organized with the support and direct involvement of the members of the Working Group on Gender realities in the OSCE region and Women's International League for Peace and Freedom (WILPF) Germany. The main goal of the conference was to launch an open discussion process of the

grave human rights violations encountered by over 21 million women and children from different parts of the world caused by numerous diverse root causes including but not limited to the impact of war, internal strife, environmental crisis, conflict, and armed violence, military aggression use of explosive weapons shrinking democratic space and political pressure with the governments, international organizations, women's and human rights groups and develop and strengthen international legal mechanism protecting such groups.

Irrespective of the fact that the burden of displacement is shared by men and women almost equally, the actual affects and the negative repercussions of living in internal displacement seem to affect women more than men, particularly in regards to livelihoods, security, health, and education. Twenty-five years after the Beijing Declaration and Platform for Action, one of the most comprehensive global policy frameworks for gender equality, women and girls are still suffering disproportionately from displacement.



The conference took place in a hybrid format, with presentations in the

offline format in Yerevan and the participation of women from Artsakh who are displaced because of the 44-day war. Women from Goris (Syunik region) and Martuni (Gegharkunik region) of Armenia who founded themselves in a new geopolitical reality and increased insecurity due to the trilateral ceasefire agreement which was signed on November 9, 2020, Women from 16 countries such as Germany, Russian Federation, USA, Kenya, Columbia, Lebanon, Turkey, Georgia, Palestine, Ukraine, Kyrgyzstan, Belarus, Afghanistan, Zimbabwe, Italy, and Armenia spoke online. The participants brought up the situation on displacement that currently exists in different parts of the world.
